What is the Local Control & Accountability Plan (LCAP) and the Local Control Funding Formula (LCFF)?



Accountability in California

- The LCFF is the formula the State of California uses to provide funding to school districts based on several factors including unduplicated students, which are English Learners, Foster Youth and Low Income.
- The LCAP is the actual district 3-year plan that is created with stakeholders to provide increased and improved services to students with the LCFF funding.
 - The LCAP drives the budget, provides transparency, and promotes community engagement
- The California School Dashboard takes center stage in the plan.
 - Used by Districts in the development of the LCAP
 - Accountability system
- But the real test is student achievement and the extent to which we are closing the achievement gap
- The expenditure of supplemental and concentration grant funds is a central focus

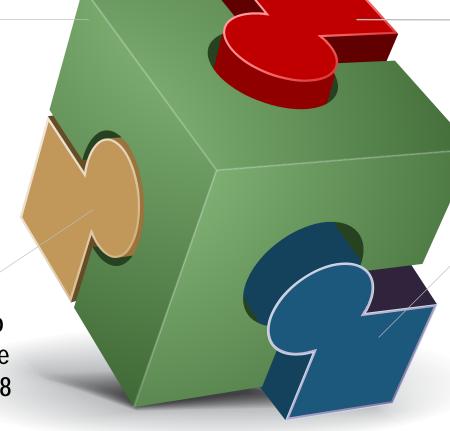
The LCAP Template

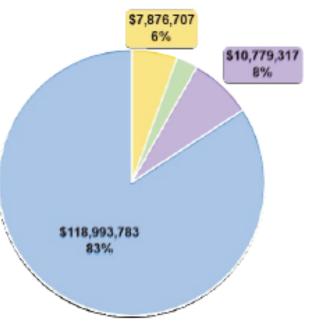

Creates a front page of the LCAP and provides financial transparency for community and families in an understandable format.



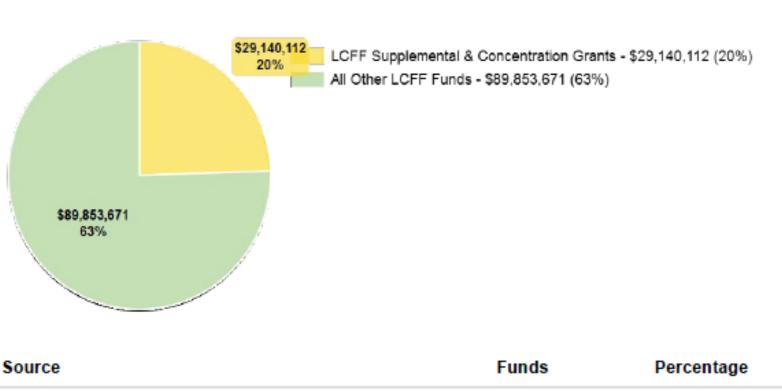
